## **WINTER LIHEAP (UTILITY ASSISTANCE)**

- **DOCUMENTATION REQUIRED:**

- 1) Proof of income for all household members 18 yrs. & older **from previous month**
- 2) State or government issued ID
- 3) Social Security Cards for all household members 18 yrs. & older, SSNs for all other household members
- 4) Birthdates of every household member
- 5) **Printed copy** of all utility bills: gas, electric, etc.
- 6) **Proof of payment** of non-electric services, if requesting crisis assistance on your electric bill (*some vendors this may not be possible*)

**Note: Other documentation may be asked for during interview, based on each situation**

- **IF YOU DO NOT HAVE INCOME:**

- 1) Proof of how bills are paid is required
- 2) **Print-out** of unemployment for all household members who are 18 & older is required

**No applications will be accepted unless  
all required documentation is obtained  
at time of interview. NO EXCEPTIONS!!**
